

## AIA Document Unit (DU) Value List

With an AIA Contract Documents Limited License, customers have access to all documents and can convert a limited number of documents to their final form during the 12-month license period. Each document is assigned a unit value whereby customers choose the documents they need for projects, up to 300 DUs per year. DU values range from 0 to 25 per document.
