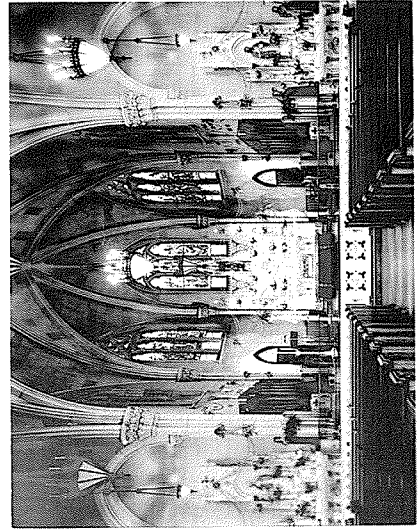

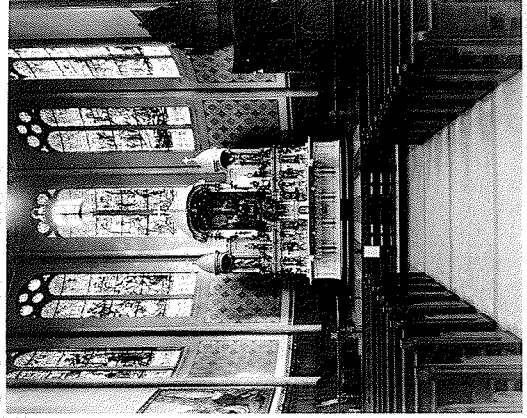
CHURCH - WORCESTER, MASS.

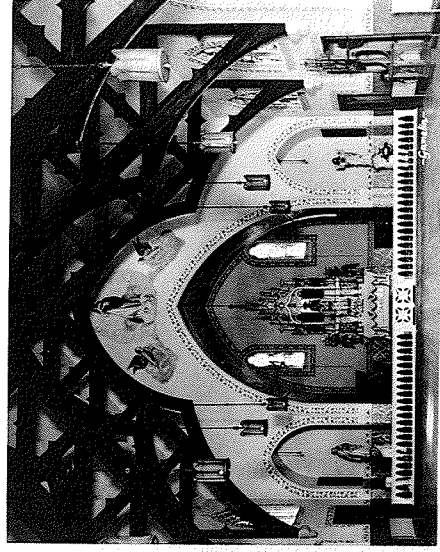
CHURCH - TURNERS FALLS, MASS.

SACRED HEART - CONCORD, N.H.

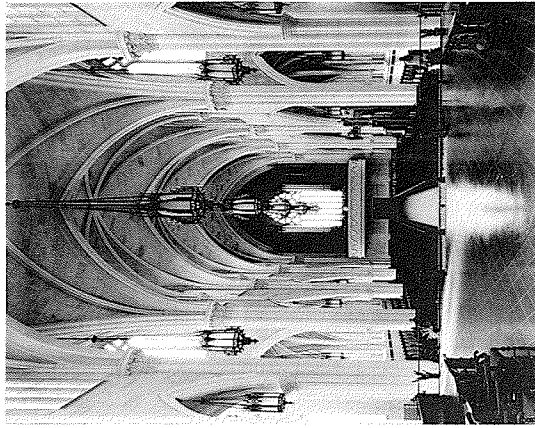

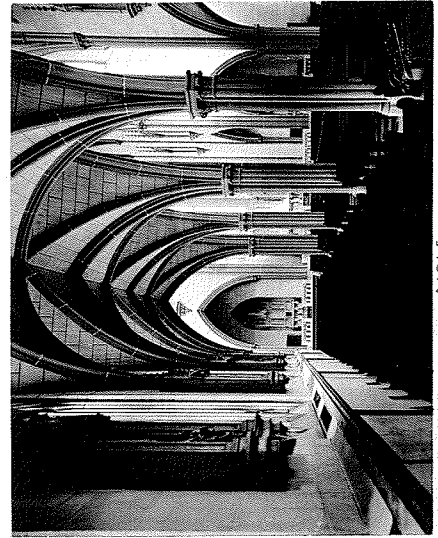
