PROFILE - JAMES J. FOLEY October 20, 1972

The Columbus Chapter has elected to submit again for favorable jury consideration the nomination of James J. Foley. The chronological history is part of the record and is in the folder. We believe that this tells only part of the story as an impersonal statistic. We will therefore fill in these gaps in a very personal way, and will endeavor to do it concisely, factually, truthfully and without embellishment.

Our candidate has for many years been the source of information and guidance for students, young practitioneers and his contemporaries. His practice is successful, well-managed and has always pioneered new techniques for improving the practice. He has willingly shared this information and data with others for the general improvement of the profession.

He is Mr. A.I.A. in our state. The Director of the Department of Public Works, the State Architect, the Director of Construction for the Education Department, the Head of the Building Inspection Department, the Head of the Bureau of Educational Research have counseled with him on professional relations and architectural matters. This is true over several political administrative changes because his relationships were purely professional on a high plane, and not political. His relationship with government has materially benefitted his profession as a whole.

We commend you to the photographs of some of his work. The firm which he directs does crisp, clean work and by reputation is known for its high professional performance. What the photos do not show is the delivery of good architecture on time, within the budget. This record helps all architects.

You should know that his other interests serve his community. He is the House Committee for the Board of the United Cerebral Palsy of Franklin County. He has been responsible for installation of many improvements to the physical plant at no cost to the Cerebral Palsy group.

He has headed the solicitation for the architects group for the Central Ohio Heart Fund with greater success each year. He chaired a section for the "Annual Giving" campaign for the Columbus School for Girls and exceeded the established goal.

He is a licensed twin engine instrument pilot who shares his avocation with others.

He is a Captain in the Civil Air Patrol which introduces youngsters to aviation as well as carry out search and rescue missions for lost or downed aircraft in Ohio.

This is a volunteer activity of time and donated use of his aircraft.

He belongs to and works on the Downtown Area Development Committee. He is an active member of the Chamber of Commerce and is active in Committee work of the Downtown Kiwanis Club.

He has an abiding interest in Education. In addition to lecturing and counseling students, he is on the Executive Committee of 100 for Engineering for the Ohio State University. The School of Architecture is in the College of Engineering at this University and he is its off-campus advocate. He was awarded the Distinguished Alumnus award in the Centennial Year of the Ohio State University.

President Urbahn appointed him this year to a four-year term on the National Architectural Accreditation Board as one of two representatives of the A. I. A. on the Board
