#### LEADERSHIP

Darren's natural leadership ability propels him into roles where he is responsible for shaping communities. He was re-elected to a fourth term as Chair of the Dallas Black Chamber of Commerce and recently named the President of Fair Park First, the non-profit managing the city-owned Fair Park — just two engagements of many illustrating how Darren's leadership blends architecture and civic responsibility for the benefit of the community.

He is leading the effort to enhance and transform 277 acres of green space in Fair Park along with the new 200-acre Harold Simmons Park projects that will shift Dallas' perception of natural recreation and public spaces for decades to come. Fair Park, a designated National Historic Landmark housing the largest collection of 1930s-era Art Deco buildings in the country, is an underutilized civic amenity southeast of downtown Dallas. As founding Chair of the Trinity Park Conservancy's Harold Simmons Park Community Inclusion and Economic Development Committee, Darren authored the Guiding Principles that define and encourage inclusive development in and around the park while he crafted a new economic development policy which was adopted by the City of Dallas.

Darren's vision for these projects opens new opportunities for area residents with impactful economic, educational and business development possibilities over the next 20-30 years.

#### INFLUENCE

Darren is a sought-after civic leader and business mentor to emerging and established entrepreneurs in the design and construction industry. He encourages and trains his staff to participate in civic engagement, teaching them to design with community focus, while investing his own time, talents and treasure back into community and civic organizations.

While serving as Chair of the Dallas Black Chamber of Commerce, Darren received an invitation from Dallas Mayor Mike Rawlings to participate on a panel discussion of Public Spaces, sharing the stage with the Park Board and the Trinity Park Conservancy Board representatives. Darren's point-of-view on the panel sparked an invitation from Mayor Rawlings to join the Trinity Park Conservancy. Mayor Rawlings additionally asked Darren to testify on behalf of business owners before the Texas State House Pensions Committee in rescuing the failing Dallas Police & Fire Pension Fund.

Darren is a recognized thought leader, author and presenter on the impact of school design in creating opportunities for students. Over 7 years ago, Darren authored "Schools as Community Spaces" published in School Planning & Management. That article led the After8toEducate Executive Director, Hillary Evans, to invite Darren to serve on the Advisory Board in the fall of 2017. After8toEducate is the first all-encompassing program to support unsheltered high school youth in Dallas.

#### PRACTICE

Darren explains his community-based design philosophy during each initial community engagement meeting stating, "Your dollar is just as valuable as any other in this city regardless of ZIP code." From that introduction, residents understand Darren is different. He consistently delivers high quality design in the toughest, most-impoverished neighborhoods through his architecture practice, insuring the same design sensitivity is demonstrated regardless of neighborhood economics. After students walkedout in protest of the deplorable conditions of their high school, Darren led the design efforts to re-imagine Dallas ISD's South Oak Cliff High School. He stepped into the highly charged volatile environment, deftly leading the boisterous community through a series of charrettes and community meetings while students and parents attracted heavy local and national media coverage, ultimately designing a school that rekindled community pride.

There is a universal truth Darren acknowledges in all of his projects — if you respect the neighborhood and residents, they will trust and participate in the process, even after years of distrust. That truth has been demonstrated time and time again, shattering status quo and leading to better environments with well-designed buildings in neighborhoods where beauty is hard to come by. Darren's ability to calm the loud voices in contentious projects is noteworthy, leading him to choose the most complex, inflamed community projects and then resolve the conflict through thoughtful design solutions. Darren's natural leadership skills are easily recognized, and he is frequently recruited to lead local organizations to facilitate planning and collaboration in groups with disparate goals and agendas. Through active listening and problem solving, he designs solutions that meet a community's need, moving impacted individuals closer to transformational opportunities.

In collaboration with the Dallas Independent School District (DISD) and local organizations, After& provides a three-pillar program that addresses the unsheltered youth that are currently enrolled in DISD high schools and support immediate needs of other homeless young adults age 14-21.

#### BACKGROUND

Darren became an architect because he saw a need to make his community better. But he realized early in his career that transforming communities involves more than the design and development of new buildings and public spaces. Civic leadership is the true catalyst that makes a difference in the community. Darren is honored to serve on multiple boards — typically as the only architect — to share his professional experience, talents and skills to make a lasting impact on communities, working with local elected officials and the people they serve.

The culmination of Darren's professional architectural career, civic leadership, and community advocacy is serving as Chairman of the Board for non-profit Fair Park First. He was the unanimous choice of internal and external stakeholders because of his demonstrated expertise and leadership on other area efforts. He will lead the board in the daily management of the park, internship opportunities for neighborhood residents and impactful development for this underutilized amenity southeast of downtown Dallas. Fair Park, created for the 1936 World's Fair and subsequently holding the largest annual State Fair in the country, covers 277-acres 5 minutes from downtown Dallas. The grounds include the largest collection of Art Deco architecture in one location in the United States. Fair Park First is responsible for the stewardship of the historic facilities. This project size and scope is unique, and Darren's role has already engaged thought leaders from New York and Philadelphia that will positively impact the surrounding neighborhoods and the DFW region over the next 20-30 years preparing for Fair Park Bi-Centennial in 2036.

While serving as Chair of the Dallas Black Chamber of Commerce, Darren received an invitation from the Mayor of Dallas, Mike Rawlings, to participate on a panel discussion of Public Spaces, sharing the stage with the Park Board and the Trinity Park Conservancy Board representatives. In this capacity, she and Darren reconnected as he was completing the Dr. Robert L.M. Hilliard Clinic for UHS. Lourdes asked Darren to serve on the San Antonio Mayor's Housing Task Force Working Group for Affordability.

#### RESULTS

Darren gives everything he has to be a leader in these communities, often elevating the contributions of others to the betterment of the organizations he serves. During his more than 15-years of civil leadership, **Darren has continually demonstrated his belief** that decisions made today must consider the future impact to the community and be prepared to take advantage of new opportunities. The organizations he has served have benefited from his leadership and are better equipped to respond to challenges and opportunities set before them.

# EXHIBIT 2: DALLAS BLACK CHAMBER OF COMMERCE DALLAS, TEXAS

### BACKGROUND

The Dallas Black Chamber of Commerce, founded November 21, 1926, is the oldest continuously operating black chamber in the United States. Darren, a Board Member since 2007, agreed to participate on the 2016 Nominating Committee to compile a slate of new board members and officers for the coming year. Individuals participating in the nominating committee could not currently hold an executive office or expect to hold an office in the upcoming year.

Due to prior commitments, Darren was unable to attend the first committee meeting. Shortly thereafter, another member asked Darren to resign from the committee so that the members could nominate him as Chairman of the Board. The members knew his calm leadership skills could help right the oldest and largest Black Chamber in the country again. Darren was unanimously elected Chairman of the Board on September 12, 2015.

#### CHALLENGE

His term began January 1, 2016, and it became immediately clear the 91-year-old Chamber was at a nadir, the lowest of low. Membership was falling, fund balances were low, and the relevance and impact of the Chamber was nonexistent. Other organization were filling the gaps, recruiting chamber members and monopolizing the market share. Chamber members were isolated from one another and disenfranchised from the business community. The Chamber's historic reputation for being at the forefront of every major economic and social change in the history of Dallas was in danger of being relegated to stories of the past.

# EXHIBIT 2: DALLAS BLACK CHAMBER OF COMMERCE DALLAS, TEXAS

### STRATEGY

DARREN L. JAMES,

Darren immediately began to renew the relevance of the chamber by realigning the organization to become a peer resource and networking organization. Under Darren's direction, the board split operations into two separate organizations with fully autonomous Board of Directors, making him the Chair of two boards.

He recruited strong financial and development professionals for the 501c3 board of directors and renamed the charitable organization the Dallas Black Chamber Center for Excellence to more accurately reflect its mission and purpose. These strategic decisions unlock the potential to shape the future for the Chamber, its members and the business community it serves.

Darren's vision for the Chamber is to facilitate business conversations, investments and economic growth in the heart of this historic African-American community. As an architect, Darren is led to create a new physical manifestation of the Dallas Black Chamber of Commerce on the corner of Dr. Martin Luther King, Jr. Boulevard and Malcolm X Boulevard – the intersection that honors the history of the community, poised for the future.

The plans for the new Chamber office four blocks from Fair Park include retail and commercial space on the first floor, educational and training rooms on the second floor. The Chamber offices and a research institute will be located on the third floor with a rooftop patio for chamber events. It is a visible investment of the Chamber into the community, magnifying the new investments planned with the privatization of Fair Park, collaborative investment from City Square/The Real Estate Council, and St. Phillips School.

In addition to building the new Center, Darren plans to retire the outstanding debt on the current dated facility, then return the parcel to green space and create legacy Pocket Park, honoring those that have come before and the difference they made in the economic climate of Dallas.

#### RESULTS

Darren has created new excitement in directing process improvements gleaned from his many years as an entrepreneur and civic leader. The Annual meetings are the place to be every October. Darren has introduced previous keynote speakers U.S. Representative Emmanuel Cleaver and political analyst

Donnan Brazile. The 2018 dinner will feature U.S. Urban League President Marc Morial. Under Darren's direction, the Chamber's keynote speaker selections have influenced other area organizations to bring the same level of prestige to the Dallas-Fort Worth business community.

He created a new quarterly event for Dallas/Fort Worth education thought leaders to share ideas and knowledge. Byron Sanders, CEO of Big Thought and three-time HBCU Male President of the Year and Dr. Michael Sorrel of Paul Quinn College have already been recognized. Dr. Terry Flowers is slated for the third luncheon.

Annual scholarship awards were increased from \$1,000 a student to \$2,000 per student, regularly awarded to 25-30 students each year.

The Annual Quest Awards Luncheon honored 12-15 entrepreneurs who exhibited tremendous business acumen and civic engagement and will be celebrating its 35th year in 2019. The Dallas Morning News and local ABC affiliate WFAA Channel 8 interviewed and recognized award winners.

Darren believes he has something to contribute to each business owner and operator regardless of firm maturity. That inclusive belief, and his leadership to the Chamber has led Darren be re-elected to a fourth term in September of 2018 for calendar year 2019.

#### CHALLENGE

Few neighborhoods in San Antonio are as distressed as the one surrounding the former Wheatley Courts. Residents and investment abandoned the area while the neighborhood suffered from failing schools, high crime and unemployment rates. The area accounts for just 1% of the city's population, but 9% of all the crimes reported in San Antonio. According to a study commissioned by the San Antonio Housing Authority (SAHA), the 250 families living in Wheatley Courts had an annual median household income of \$5,000.

As the project replaced an existing housing community, current residents were given first right of refusal to return upon completion. Darren worked patiently with frustrated residents who were relocated in temporary housing, and then relocated again upon completion.

#### STRATEGY

San Antonio's Eastside community is the only area in the country to have received all four White House Neighborhood Revitalization Initiative grants; Choice Neighborhood, Promise Neighborhood, Byrne Criminal Justice Innovation and Promise Zone.

# EXHIBIT 3: EAST MEADOWS APARTMENTS SAN ANTONIO, TEXAS

The new vision for Wheatley Courts, now renamed East Meadows, made the neighborhood a walkable, sustainable, mixed-income and intergenerational community with multi-family residences reflecting the unique history of the Eastside using architectural elements of San Antonio's diverse cultural heritage; a mix of Spanish Colonial, Craftsman Bungalows and Federalist styles. Darren led the effort on Phase 1, a 215-unit multi-family complex with 1- to 4-bedroom configurations to meet the desired needs of expected future residents.

Darren's community engagement skills were displayed as he led public and private meetings with residents and stakeholders who shared their visions and dreams for quality housing and opportunities for the area's residents.

## OUTCOME

The East Meadows housing community meets LEED design criteria, complies with Build San Antonio Green sustainability initiatives, and achieves the coveted Enterprise Green Communities designation. As intended, the development houses a diverse mixed-income levels from all walks of life including former Wheatley Court residents, U.S. Service Personnel from Fort Sam Houston and working families from downtown San Antonio's central business district.

Under Darren's leadership, the design of East Meadows reflects the diversity in residential architecture in San Antonio. The new apartment community easily blends architecturally within Eastside's historical context, complimenting infill housing by other developers and investment from the remaining neighbors.

# EXHIBIT 4: BILLY EARL DADE MIDDLE SCHOOL | DALLAS, TEXAS

#### CHALLENGE

Billy Earl Dade Middle School was housed in a 1920's era Art Deco elementary school near historic Fair Park in South Dallas. The building did not have the required laboratory or performing arts spaces, and classrooms did not meet the Texas Education Association Guidelines. Students attended classes across the street from a strip retail center that sheltered prostitution and drug use.

In response, DISD requested a new school that would celebrate the African-American heritage of the community as well as the legacy of the school's namesake Billy Earl Dade. As design progressed, the district decided to add students from the nearby Pearl C. Anderson Learning Academy to the school, doubling the enrollment and creating community tension for residents, students, educators and administrators.

Changing school district leadership brought even more complexity to the project. The new Dallas ISD Superintendent quickly lost the confidence of the board and the Dallas community, resigning shortly before the school opened. The principal at Billy Earl Dade spent most of his time resolving conflict and hurt feelings only to be reassigned to another school before Dade opened, leading to a carousel of principals at the school from the time it opened in 2013 until the fall of 2017.

# EXHIBIT 4: BILLY EARL DADE MIDDLE SCHOOL DALLAS, TEXAS



#### **STRATEGY**

Combining two schools' frustrated parents and educators into one community meeting could have created insurmountable conflict in the planning process. Instead, Darren met with each school community separately to build trust that their voices would be heard. As the design process moved forward, **Darren was able to bring these two disparate groups together around their common desires in this new educational facility.** 

The design team worked with archivist from the Smithsonian Institute and discovered a Gee's Bend Quilt as the model to tell this story. In the African-American culture, quilting has been used for centuries to pass down stories of triumph. The façade of the school, angled and articulated, provides the textural context of a story-telling quilt. Black culture is even showcased in the masonry articulation on the gym punctuated by lights in the wall.

## OUTCOME

Despite the initial concerns of the community, **Dade Middle School has stabilized the neighborhood, spurred residential development in the area and created a cohesive educational community supporting students to reach improved academic performance and outcomes.** In the spring of 2018, over 600 Dallasarea men responded to a call for volunteers to mentor male students. Education Secretary Betsy DeVos visited Dade as an example of a successful urban school and Dade Middle School was named an ACE academy for improving academic performance and test scores.

## CHALLENGE

Sam Houston High School is an institution in San Antonio's predominately African-American Eastside. It was the only high school for black students prior to desegregation, and many pillars of the community walked through the halls. But the school suffered from declining enrollment, poor academic performance, apathetic students and disengaged parents. Through the efforts of community leaders, elected officials and a vocal alumni group, Sam Houston was rescued from the brink of closure in the spring of 2009 to remain a place of refuge for students from a chaotic home life and economic instability in the community.

Darren's team was tasked with managing the expansion for the-school-within-a-school New Tech Curriculum, renovate the existing general education areas, and design a 25,000 sq ft addition to house a growing JROTC and Career & Technology Program — all while maintaining an operational school. None of the classes are programs were postponed or delayed during the less than 14-month construction period.

#### STRATEGY

Darren was invited to lead the design efforts for this community particularly because of his demonstrated abilities in community engagement and educational design expertise. Cultivating community feedback and processing the information during the design process to meet the schedule and budget.

Darren learned the students in the general education areas felt disconnected from the decision-making. But his community engagement meetings gave them a voice in the successful design solution.

Darren's team met, listened to and heard from students and parents, eventually showing them how their ideas were incorporated in the design, changing their attitude toward improvements.

## OUTCOME

The students and community have reacted positively to the new spaces, enrollment has increased by 10% and test scores have increased. The school is no longer on the District's closure list and is now meeting Texas State Academic Standards. The CTE Addition reflects the parents' commitment and new outlook providing excitement and celebration for the students' futures.

Darren made such a great impression on the school district executive leadership, campus leaders and the community that upon approval of a subsequent bond election in 2017, he was asked to continue his efforts on an even larger program that began in the spring of 2018.

# EXHIBIT 5: SOUTH OAK CLIFF HIGH SCHOOL | DALLAS, TEXAS

#### CHALLENGE

Because of his proven leadership and influence, Darren was offered his choice of Dallas Independent School District assignments. He chose the most controversial project in the 2015 Bond Package mired in the most conflict — South Oak Cliff High School, originally built in 1952.

Previous renovation programs insufficiently addressed all of the deferred maintenance needs. The situation reached a boiling point December 2015 when students walked-out in protest of the deplorable conditions. The educational spaces were inadequate and below the technology standards of other schools in the district.

The passion of the students motivated parents and the alumni association into action demanding a better school facility, soon attracting local and national media. The community's frustration and distrust, fueled by years of failed renovations and broken promises, led to vocal disruptions at DISD board meetings, prompting the school board to act. A 2015 Bond allocated \$9 Million to the renovations at South Oak Cliff High School, but the budget was woefully insufficient to fix previous renovations while addressing the lack of educational equity.

Community meetings were not civil. There were screaming matches and name calling that tried the patience of both sides. Darren led these meetings, standing in the middle of conflict answering countless questions from students, parents and community leaders. **His empathic listening and supportive suggestions calmed the community. They were distrustful of the district, but they were convinced Darren would fight and advocate for the school.**

## STRATEGY

Without a contract, Darren and two KAI Texas staff members participated in 3-day charrette to ensure continuity in planning once an agreement was in place. It was immediately clear that needs called for a full school replacement.

Darren worked diligently to increase the budget from the revised earmark of \$13 Million, past the promised \$25 Million, to a final total project budget of \$52 Million. The revised budget allows for the creation of new learning environments for career and technical training, a collegiate academy, fine and performing arts as well as a new athletic facility with 2,000-seat gym. A grand, three-story, light-filled concourse nicknamed the Legacy Concourse celebrates the school's student athletes terminating at the Bear Den, a new student entry a gathering spot for academic and social activities. "Darren L. James has been instrumental in providing support to the South Oak Cliff High School community. Whenever called upon, Darren and his team have unselfishly donated their time and resources. # OUTCOME

The community and alumni are excited about the investment in their children's future and the promise to future South Oak Cliff families. The recommended renovations Darren proposed ensures this legacy high school can restore the rich academic and athletic tradition to the Oak Cliff community.

# EXHIBIT 7: HIGHLAND HILLS BRANCH LIBRARY DALLAS, TEXAS





The previous Highland Library Branch was a prized community asset for the economically distressed neighborhood in South Dallas where the digital divide is prevalent. Area residents do not typically have computers in the home, meaning library computers are in heavy demand for school studies and research, job searches and general web-surfing.

The site of Highland Hills is immediately across the street from one of the most crime-ridden apartment complexes in that part of South Dallas. The community had been neglected for so long, the residents no longer believed they deserved or could protect such a facility. They were reluctant to even engage in conversations about their desire for a library.

Darren delivered the Highland Hills Branch project while the City of Dallas was in a budget crisis, and the Dallas Public Library experienced three different leadership appointments, complicating the project with shifting priorities and timelines.

## STRATEGY

Darren's focused dedication navigated the twists and turns, meeting with multiple library leadership and city staff throughout the project to gain insight on their hopes, dreams and desires.

In meeting with residents and users, Darren and his team visited the existing branch to get a feel for how the users utilized the existing facility, visiting at different times of the day to gauge usage patterns and demographic data.

Darren led the conceptual process meeting with key stakeholders, the local elected official and residents. The initial design included a curved floor-to-ceiling glass wall running the length of the library circulation area looking out onto a well-landscaped natural area. During the course of design Darren repeatedly heard that the building would be vandalized, or bullets would shatter this expanse of glass. But Darren's philosophy of equitable design regardless of the economic composition of the surrounding community was persuasive, and the glass wall remained.

# EXHIBIT 7: HIGHLAND HILLS BRANCH LIBRARY DALLAS, TEXAS



## OUTCOME

The 16,500 sq ft library was sited to take advantage of sun angles and sits on the highest point of the site. The project is LEED Silver, utilizing a geothermal system with forced air fed under a raised floor in the circulation space for ultimate flexibility.

Despite initial concerns, the library hasn't experienced any vandalism or broken windows. The Highland Hills Branch Library has been deeply embraced by the community, and other library systems have looked to the facility for inspiration and best practices. It is the crown jewel in the Dallas Library system, recognized regionally as one of the best branches in the city.

Highland Hills has hosted political debates, lectures, community organizations, dramatic performances and even musical events, creating transformational neighborhood pride with patrons and the community.

# EXHIBIT 8: CORTEX STATION ST. LOUIS, MISSOURI

## CHALLENGE

The 200-acre CORTEX Innovation Community campus is the Midwest's premier innovation hub of bioscience and technology research, development and commercialization, serving as the anchor of St. Louis' growing ecosystem for innovative startup programs and established companies.

In 2015, founding members of Cortex met with St. Louis Metro to create a new transit station in the midst of the campus with the plans to provide a portion of funding through a Public Private Partnership. Citizens for Modern Transit and the Great Rivers Greenway joined the partnership with Cortex and St. Louis Metro.

#### STRATEGY

With all of these competing interests, Darren led the station design team to incorporate each of the funding partner voices, as well as the client and the community liaisons wishes for a new light-rail station and trail to serve the growing science and tech hub.

In addition to creating a new stop on an existing, operational line, Darren's design team was also asked to create a new canopy design celebrating the Cortex location. Bi-State Development, the parent organization for St. Louis Metro, is very familiar with Darren's design expertise and sensitivity, hiring his team specifically for this assignment. They knew Darren would create an iconic design that embodied the vision and future cultivated in this incubator hub.

# EXHIBIT 8: CORTEX STATION ST. LOUIS, MISSOURI

Darren's ability to negotiate with strong-willed stakeholders was required when various founding organizations attempted to sway decisions to their benefit. Darren adeptly led the various private organization leaders and the St. Louis Metro technical team through a process that culminated in a station that delivers a true mobility solution.

## OUTCOME

Stretched fabric canopies simulate the airiness and excitement of the research conducted on the Cortex campus and is the first use of this material in Metro's system. It also pays homage to an outdoor gathering place near the new infill station. During the course of design, Darren received a call from a designer at HOK working on an adjacent building seeking collaborative input on how the station would work with the building he was designing for his client. The building's façade is one of the first in the region with multi-chromatic skin that changes according to sun and viewing angle. It is a direct play from the innovative district and the forward-thinking infill station.

The opening of the Cortex station marks the first section completion of the Chouteau Greenway — a hike, bike and walking trail that will connect the Gateway Arch to Forest Park. The dedication and ribbon-cutting of the Cortex Station occurred on the 25th anniversary of MetroLink's light-rail system in 1993.

All of the partners — local, state and federal as well as the private organizations — spoke to the importance of creating a mobility solution allowing workers and residents easy access to the metropolitan area.

# EXHIBIT 9: SAN ANTONIO EASTSIDE PROMISE ZONE SAN ANTONIO, TEXAS

### CHALLENGE

Once a thriving community, the Eastside of San Antonio has experienced hard times. The neighborhood includes 22-square-miles immediately east of downtown San Antonio. According to a 2015 U.S. Census, the predominately African-American community of Eastside includes over 81,000 residents; 10% are unemployed, 31% live at the poverty level, and 29% of the residents over age 25 do not have a high school diploma.

In 2014, President Barack Obama selected Eastside as one of five Promise Zones, a national place-based initiative designed to revitalize distressed neighborhoods through job creation, increased economic activity, improved educational opportunities and reduced violent crime. Promise Zones are a 10-year federal designation that do not come with federal funding, but provides federal staff support to connect local leaders with resources, five AmeriCorps VISTA volunteers, technical assistance and preferred access or extra points on various federal funding streams, as well as business hiring tax credits and incentives. The Eastside Promise Zone currently has about \$90 Million in federal grants managed by various San Antonio-based organizations, such as the United Way of San Antonio, Bexar County and the San Antonio Housing Authority.

## STRATEGY

Darren felt it was imperative that he be part of the transformation in this previously declining community. A single project was insufficient to truly move the needle. For the community to be healthier than when he arrived, Darren looked at the entire Eastside area holistically where each subsequent project builds upon the success of the preceding. The Promise Zone's initiative provides housing, education, health care and commercial services to current and future residents with an overlay of social services.



Through his direct efforts working in concert with local civic leaders and organizations, the underserved neighborhood is making a comeback. Darren is the only architect to have successfully completed 4 projects in the East Side Promise Zone.

Darren's work and effort have made such a tremendous impact in the neighborhood that the former CEO of the San Antonio's Housing Authority asked Darren to serve on Mayor Ron Nirenberg's Task Force on Affordable Housing. Darren's leadership is admired and appreciated in the community and the residents of San Antonio have adopted him as one of their own. He has led projects that transformed this community to a neighborhood of choice for new transplants and longtime residents. **The four projects** — a high school, apartments, a credit union headquarters and community-based clinic — leverage each other, providing services long vacant from this area of town.

Darren embraces the opportunities in this community, working with local neighbors and community residents, as well as local organizations and municipal departments, to deliver projects that are truly reflective of the needs of the assignment and the needs for the area. He is proud of his team's participation in the four transformative Promise Zone projects, delivering new spaces and facilities that will serve the Eastside and make the community more vibrant in the future.
