#### President Elect, Texas Society of Architects, 1966

The Nominee was elected to office in November 1965 and assumed duties as President of TSA on January 1, 1967.

As President-Elect the Nominee directed the activities of the Commission on Professional Society and those of the Chapter Visitation Committee.

All Committees under this commission concerned the internal workings of the TSA and included ByLaws, Nominating, 1966 Annual Meeting, Judiciary and Fellowship.

The TSA Chapter Visitation Committee, 1965-1967, one of the most important in the TSA, is responsible for providing visiting experts in any professional or organizational capacity requested by the Chapters during Chairmanship in 1966 professional programs were provided in all seventeen Chapters of TSA.

## President, Texas Society of Architects, 1967

Initiated Architects Technicians Cirrculum in four Texas community colleges through the Texas Society of Architects Education Committee. Efforts have been successful and other colleges expressing keen interest.

Continuing the "Architects in Practice" education through three state wide educational Seminars. These Seminars were well attended and highly successful.

Formulated effective professional political action group within the Texas Society of Architects' membership. This group was charged with responsibility of upholding the professional integrity of the Architect on state legislative level.

Successfully stopped the AGC from voiding AIA document A201 on a state legislative level.

Continuing the effort to provide the Architect profession with a Statute of Limitations law. The ground work on this effort should produce effective legislation in the next session.

#### REGIONAL COMMITTEE ASSIGNMENTS OF NOMINEE

## Member, Insurance and Sureties Committee, 1961-1963.

Served as a member of Committee during period of surveying of professional insurance requirements of the profession in Texas and assisted in preparation of reports to the profession on lien laws and bonding procedures.

# Member, Office Practice Committee, 1961-1962.

Assisted in development of State-wide survey on Office Practice Procedures which resulted in an important report which analyzed the cost of doing business by firms of varying sizes in all parts of the State.

#### Fee Structure, 1962

Member of important committee which conducted nation-wide survey of recommended minimum fees and developed a revised statement which was adopted by the TSA.

# Nominating Committee, 1962, 1963 and 1967.

Member in 1962 and 1963 and Chairman in 1967 of the committee responsible for selecting future leaders of the profession in Texas.

#### Public Affairs Committee, 1963-1967

Member and later Chairman of this most important activity designed to maintain liaison with all agencies of State government. The nominee was a major contributor to the activity which lead to the framing of important new legislation creating a State Building Commission, modifying existing statutes and proposing a number of other forward-looking pieces of legislation.

#### Statute of Limitation of Liability Committee, 1964-1966.

Chairman of special committee which surveyed all national laws in this area and recommended a model law to the Texas Legislature.




