In 1956 the nominee began an exemplary chronicle of voluntary civic activities and governmental appointments. That unique career of service, now approaching three decades of providing valuable and enduring benefits to others, has been acknowledged and saluted in fourteen formal commendations from community and domestic and foreign governmental entities. His distinguished public service has abundantly enriched the community and clearly advanced the prestige of the profession.

For nearly 18 years Mr. Terasawa was the only architect member of the Board of Building and Safety Commissioners, City of Los Angeles. The commissioners elected him their president or vice president eight times. His valued professional counsel and his concern for citizens' well-being significantly influenced public safety issues and gave the architect's discipline to board decisions.

The nominee invaluably aided the long-term movement of the construction industry to reorganize and modernize the city's Building and Safety Department and uphold its well known integrity. He is an authoritative and available reference for architects in their dealings with that department's and city hall bureaucracy.

Mr. Terasawa led the successful efforts to have the city adopt the Uniform Building and National Electric Codes, to update seismic safety standards and to furnish consistent code interpretations. He is recognized as a definitive source on testing procedures for building methods and materials and has expedited the process for securing city building permits and plan check approvals.

For 25 years the nominee has skillfully helped shape the dynamic growth of Little Tokyo, a 67-acre downtown Los Angeles neighborhood of retail, residential, religious, cultural arts, commercial and entertainment buildings. His guiding influence was indispensable in the area having become one of the city's most popular attractions for investors and thousands of shoppers, museum-theater attendees and diners.

Mr. Terasawa's volunteer community involvements embrace a wide spectrum: urban planning, cultural arts, child service centers, assistance for the disabled, expanding construction industry employment opportunities for minorities and the strengthening of international relationships.

Special Service to Construction Community:

The nominee, as a Los Angeles city Building and Safety Commissioner for nearly two decades, reviewed thousands of appeals to Building and Safety department decisions. He presided over hundreds of public hearings on code changes, new construction materials and methods, low-cost affordable housing, earthquake preparedness, solar energy and barrier-free planning. In these deliberations it was critical that the nominee, as the only architect on the Commission, would consistently provide the disciplined reason and logic of the profession to the Commission's rulings. Because of the nominee's diligent leadership on the board, these rulings were based on fairness, objectivity and sound technology, a most favorable image of the profession was established and the public recognized the unique contribution the architect brings to enhancing the quality of life. As a truly dedicated and effective Commissioner, Mr. Terasawa has rendered a notable service to the profession and the Los Angeles Chapter's Building Code Committee.

Architectural Practice:

The nominee has efficiently managed an architectural practice that has endured for more than a third of a century and is widely recognized for its high quality documentation, construction technology and reprographic automation. The firm, whose partners are licensed to practice in 14 states, is involved in the design and construction administration of industrial, commercial, educational, religious and medical buildings. These architectural commissions reflect design excellence, environmental compatibility and budgetary parameter comformance. The nominee's firm has also undertaken consultation assignments on construction litigation, energy conservation, life cycle costing, real estate research and planning, restorative design and innovative solutions to complex problems in the design of facilities for complicated manufacturing processes.

Education:

Mr. Terasawa demonstrated a special commitment to preparing and presenting his lectures in the Professional Practice course during his three years (1960-1963) on the University of Southern California (USC) School of Architecture faculty. At that time the school was practically the sole source of all architects practicing in Southern California. Under his tutelage USC students were solidly grounded in construction documentation, material technology and construction processes.

Science of Construction:

In 1964 Mr. Terasawa designed the First Methodist church in South Gate, Calif. on a site directly under the busy flight pattern to Los Angeles International Airport. Because a quiet, meditative environment for worshippers was mandatory, noise suppression was a challenging design requirement. The design solution joined massive, 50,000-pound precast concrete slabs to form the roof. These panels were cast on the site in holes carefully plastered to provide slabs that met precise specifications. Cast one on top of another, four nested panels formed each side of the angled A-shaped roof. The slabs furnished excellent acoustical control, a prayerful sanctuary conducive to devotion and a warm interior-exterior aesthetic appeal. The project was constructed within severe budget limitations. Consecrated nearly 20 years ago, the church still serves a thriving congregation. Its design and construction were reviewed in a 1964 "Southwest Builder and Contractor" magazine article. (See Section 5 for photographic illustration)

Historic Preservation:

The nominee was largely responsible for the restoration of the historic San Fernando Mission Chapel in San Fernando, Calif. The mission chapel, first erected in 1806, destroyed by an earthquake in 1812 and rebuilt in 1818, had to be restored a second time in the early 1930s after deterioration from erosion and disrepair. It sustained heavy damage in a second earthquake (1971) and was condemned by the city's building department. Before demolition work commenced, however, practitioners from the nominee's firm made numerous trips to the site. They took precise measurements and meticulously studied the structural detail. Pictures from the mission archives were carefully scrutinized. As a result of this research, the nominee's firm compiled several hundred photographs for the church records. Particular attention was paid to interior colors in the altar area and on the walls. Many of the original wooden beams and corbels were identified for salvage and were re-used in the new structure. By code, walls of double steel-stud frame replaced the adobe bricks and were given an adobe hue to resemble the original exterior thickness and color. Always guided by this painstaking concern for accurate detail, the firm designed an exact replica of the mission chapel. It stands on the original site today and provides a worshipful ambiance for regular parish liturgical ceremonies. (See Section 5 for photographic illustration)

Additional:

Mr. Terasawa, on trips to Japan, participated in many meetings dealing with building code standards. These resulted in the revision of the Los Angeles city elevator code and in changes in the Japanese building code pertaining to earthquake hazard reduction in existing structures.

During his university studies, the nominee was elected to the freshman scholastic fraternity, Phi Eta Sigma, and also joined Scarab, the architectural fraternity.

2. Describe the nominee's specific achievements in the field of public service that are considered notable contributions to the advancement of the profession:

For more than 17 years Mr. Terasawa served on the Board of Building and Safety Commissioners, City of Los Angeles. This dedicated service, longest in the commission's 60-year history, constituted inestimable value to the profession.

In concert with the structural engineers association and city building officials he obtained the vital and definitive code amendment (Chapter 68): "Earthquake Hazard Reduction in Existing Buildings." His many conferences with architects and engineers in Japan regarding seismic safety standards for elevators resulted in revisions to the city's Elevator Code. Mr. Terasawa has constantly promoted and achieved the updating of code regulations for fire protection of stairshafts and exit ways and grading hillsides to minimize landslide and flood damage.

Mr. Terasawa is widely regarded in Los Angeles as an authoritative source of information on code interpretations and variances. His expertise is regularly sought by the architectural profession as well as other members of the construction community. Also, his participation as a member of the Mayor's Construction Coordinating Committee greatly improved the relationship between construction industry practitioners and the city's Building and Safety department.

Another admirable public service the nominee renders stems from his significant contribution to the expanding vitality of the thriving 67-acre, multi-use area known as the Little Tokyo community which is celebrating its centennial anniversary in 1984. It is located a short distance from Los Angeles city hall. As an original member of the Little Tokyo Community Development Advisory Committee, founded in 1969, Mr. Terasawa provided both valuable professional input toward the preparation of a master plan and continues to give technical guidance in the siting, design and construction of individual projects with the landmark redevelopment area.

"Little Tokyo covers about seven blocks. It is rich in heritage--with Buddhist temples, the Japan America Theatre, the Japanese American Cultural and Community Center and the George J. Doizaki Gallery. It is rich in food--with about 70 restaurants. It is rich in merchandise--with shops of many kinds. And particular-

ly right now it is rich in entertainment—with many events of the Olympic Arts Festival." (Los Angeles Times, June 2, 1984) The festival was a 10-week, \$10-million cultural component of the XXIII Olympiad, produced by the Los Angeles Olympic Organizing Committee. It brought performers and exhibitions from all over the world to Southern California. Some 145 artistic companies gave 400 performances from early June through early August, 1984.

As its Building Committee chairman since 1971, the nominee successfully guided the planning, design and construction of the \$15-million, multi-use Japanese American Cultural Community Center. This ethnic complex, largest such facility in the nation, serves about 290,000 Japanese Americans plus a greater Southern California population of some 11 million. The center includes a six-story office and exhibit building, a plaza designed by Isamu Noguchi and the 850-seat, all-purpose Japan America Theatre.

The nominee significantly improved the design of the theater by insisting that special features be included, e.g., latest acoustical, lighting and staging systems, that catered to the needs of the performers. The result has been a theater appealing to both audience and artist.

Now in his 20th year as director of the Goodwill Industries of Southern California, Mr. Terasawa has donated untold hours to helping handicapped persons enhance their self respect through specialized work projects. In this organization an average of 800 handicapped individuals repair and remake various goods daily. Annual sales of these items total some \$3.6 million, about 90% of the group's yearly budget.

In his volunteer duties with this Goodwill unit--it's always in the top three, nationwide, of similar Goodwill organizations--the nominee provides valuable professional guidance for the construction of Goodwill stores, workshops and offices which are used in the group's highly regarded rehabilitation programs for the handicapped. This commitment to assisting others reflects a basic human virtue beyond the profession of architecture. At the same time, the nominee's longstanding involvement in this program surely redounds to the advancement of the profession he so ably represents.

For 15 years Mr. Terasawa has had a prominent leadership role in the Los Angeles-Nagoya sister city program. He represented Los Angeles' mayor in two goodwill mission trips to the Japanese city to promote cultural exchange projects and expand trade between the two cities.
