# **Creating the Coalition of Community College Architecture Programs [CCCAP]**

Randy Steiner, AIA has a vision that the architectural profession must include the currently underserved community college architecture program graduates who seek to become architects.

While shifting her own direction from residential architect to full-time faculty member in a community college architecture program [CCAP], Randy identified a oadblock that prevented her graduates from transferring to accredited schools of architecture [SOA]. Faced with the "problem", she began a three-year research effort in 2009 to identify all the CCAPs in the country and prepared a survey. In 2012, she invited the entire database to Washington DC to gather with support of her membership in the AIA National Diversity + Inclusion Council.

The Coalition of Community College Architecture Programs was created on September 22, 2012 with 22 CCAPs and became a 501.3(c) in 2014. Since the creation of the CCCAP, over 50 of 122 CCAPs have identified at least one articulation agreement with a school of architecture. Texas has established a state-wide agreement with its nine CCAPs. According to CCCAP surveys, enrollment has continued to increase since 2014.

Representation of diversity continues with over 1/3 of the average number of graduates self-identifing as minority in race or culture. This translates to roughly 433 minority graduates a year seeking to become architects.

# **Serving the Profession [AIA leadership]**

SUMMARY OF ACHIEVEMENTS

Randy grasps the power of teamwork with architects as environmental stewards and tools for joy.

She seeks ways to promote the value of good architecture. As President of the Potomac Valley Architectural Foundation [PVAF] for five years, she introduced a new event, the "PVAF Golf Outing," as a fundraiser and a bridge between the AIA Potomac Valley membership, the University of Maryland alumni, and the construction industry to spend a day together. It has consistently raised over \$4500 since 2013.

As a President of the AIA Potomac Valley [AIA PV] chapter, Randy created new events. She created the AIA PV Architecture Week and the AIA PV Architectural Film Fest, the AIA PV Board Retreat and the AIA PV Women Architects Dinners. Whether as a Global Village volunteer with Habitat for Humanity in Senegal or as a historic tour guide in DC, she is activist, eager to promote architecture.

# Advancing Architectural Education at a CCAP as a Mentor and Professor [Montgomery College]

Randy believes that early in an architectural education, one must learn what's important in the office and on the building site. She revised curriculum and added courses. She formed an Advisory Board of local architects and award programs during her 27 years as program coordinator at Montgomery College, Rockville, Maryland.

She is a daring risk taker. To energize the public about energy conservation she developed a "Principles of Sustainable Design" course in 2002 which was attended by UMD SOA students as well. In 2007, she shaped a GREEN WEEK with guest speakers. She was the first LEED AP ther college and helped students study for it.

An advocate, for students, she began the first MC Student Architects Club [SAC] and design competitions. [All AIA and ACSA contests were restricted to 3rd year ACSA (Association of Collegiate Schools of Architecture) member school students only.]

MC Outstanding Educator Award and AIAMD Outstanding Educator Award were bestowed on her.

# **Creating the Coalition of Community College Architecture Programs [CCCAP]**

# **Background**

There was a lack of articulation relationships between Montgomery College [MC] Architecture Program and the four local university schools of architecture in Maryland and Washington, DC. [University of Maryland (UMD), Catholic University of America (CUA), Morgan University, and Howard University.]

With no way to share best practices among community college architecture programs [CCAPs] and no list nor means of contact for the CCAPs nationally, each CCAP was isolated.

The professional community, AIA [local, state, and national], local high schools [career, guidance, and faculty] were unaware of the MC Architecture Program.

#### **Results:**

# **Development of a Database:**

In 2009, Randy began to research on-line the CCAPs which offered Associate Degrees. She identified their contact person, their title and email address, telephone number, website and curriculum.

# **Collection of Data via a Customized Survey of CCAPs:**

30-question survey was prepared and distributed it to the list of 127 programs in 2010. By 2012, 71 surveys were returned and by 2014, 122 surveys had been returned. This was a 97% return!

#### Valuable Resource of information about CCAPs:

The survey includes data about the breakdown of full-time/part-time faculty, number of faculty, number of registered architect faculty, number of entering majors, number of graduating majors, percentage of minority faculty and students, relations with AIA chapters, transfer agreements, cost per credit, and website.

# **Continuous On-going Data Collection:**

Sixteen more CCAPs have been identified as of July 1, 2019.

# Available data about Student Population and Specifics among CCAPs nation-wide:

This data is based on information submitted by faculty members and administrators of from community colleges; it is not for public distribution.

# **Expanding the CCCAP to link the Underserved + the Profession**

#### **BACKGROUND:**

To establish a new organization which had no precedent, several steps needed to be taken. There was no readily accessible source of funding to sponsor meetings, publications, mailings, and office expenses for Steiner's use. Certain software programs needed to be purchased to create newsletters and flyers and it was not acceptable to use her College computer and software for non-academic purposes.

There was no sense of "legitimacy" or "official legal status" available which limited CCCAP's ability to accept donations or be supported by federally-funded schools, and sponsors. An analysis of how to become a non-profit organization was conducted by Steiner which included meeting with executive directors of other non-profits. Lastly, there was a lack of by-laws and governance policies which narrowed long-term planning of CCCAP.

#### **RESULTS:**

# **Successful Acquisition of Pro-Bono Legal Services:**

In 2013, Randy negotiated the pro bono legal services of Paul Alpuche, Esq. in order to create a 501.3(c) non-profit organization. Legal documents and fees required by federal and Maryland government were executed with advice from Andrea Rutledge, former NAAB Executive Director.

# **Began Founders' Club:**

To fund the \$4000 required for the licensure and fees, Randy became a tireless fund-raiser. A "Founders' Club" was created to sponsor the CCCAP. Within five months, the funds were successfully collected.

# Formulated By-Laws and Membership Categories:

The first board were invited by Randy. It included community colleges from New York, California, Illinois, Texas, Ohio and Maryland. Membership categories include CCAPs, universities and colleges of architecture, corporate sponsors, individuals, and students. Dues-paying membership has risen to 36 CCAPs with 2 Corporate Sponsors [Autodesk and Graphisoft] in the four years since dues have been collected.

# **Created Recognition of CCCAP on Social Media:**

Sites on Facebook, Instagram, and Twitter were established by Randy in 2016. A website at www.cccap.org was established in 2014 sharing news, events, student design competitions, and conferences.

#### **Established CCCAP Annual Conferences:**

Since 2012, the CCCAP has held an annual conference on the Saturday of the AIA National Convention at the same city. In 2017, a two-day conference was held in Austin, TX.

CCAP faculty network, learn about NCARB, AIA, ACSA, and NAAB developments, and share presentations. Guest speakers such as Carl Elefante FAIA, 2018 AIA National President and Stacey Bourne FAIA, NOMA have addressed the group with their vision of the future of the profession.

# Crafted CCCAP Student Design Competition for 1st + 2nd Year Architecture Students:

One CCCAP objective was to develop a design competition open to students of 1<sup>st</sup> and 2<sup>nd</sup> year only. The first CCCAP Student Design Competition was held in 2015.

# Serving the Profession: AIA Leadership [National] AIA Diversity + Inclusion Council [DIVCO] Member 2010

#### **BACKGROUND:**

The AIA Board 2009 established an AIA National Diversity + Inclusion Council. According to the AIA 2009-2013 AIA DIVERSITY ACTION PLAN: "In response ... and in cognition of the opportunity inherent in increasing the number of qualified professionals, the AIA National Board has identified the establishment of a more diverse, inclusive profession as a key strategic initiative. By embracing the diversity unique to this nation, the architecture profession will gain access to new talents and new insights to address the critical issues of our time and future generations. The outcome will be a strengthened, more highly valued profession capable of reaching into constituencies previously underserved."

A timeline, set of metric-es and milestones, strategies, and actions were established for 2009 through 2013 by AIA Board 2009. In 2010, under leadership of Stacy Bourne, FAIA Chairperson, five committees [LGBQT, International Licensure, Pipeline Development, Women's Leadership, and Strategies] were created.

Randy was assigned as Co-Chairperson for Pipeline Development and Women's Leadership Summit 2010.

#### **RESULTS:**

**Creation of Display System for DIVO Committee**: A portable exhibit system to display the 30"x30" informational posters and poster format for Convention Miami 2010 were her responsibilities.

**Preparation of Women's Leadership Summit 2010 NYC brochure:** She edited the brochure of speakers and scheduled the Summit format for the 100+ attendees.

This was the first time that Mattel created a doll who was an architect. A "Barbie Dreamhouse" Design Competition was sponsored by AIA to to promote architecture as a career for girls.

Promotion of First Women in Architecture + Design ATHENA Award to Lori Garrett AIA: Under her guidance on the PEC Committee, the first "Women in Architecture and Design ATHENA Leadership Award" was promoted through news releases nationally. The award to honor women dedicated to environmental design, was given to Lori Garrett AIA, at the "2011 Women's Leadership Summit Kansas City."

**Database of TEACH [Transforming Education with Architecture in Community High Schools]:** Together with John Poole AIA, Randy focused on research and documentation of such programs nation-wide. The research was distributed to AIA state chapters nationally.

# Serving the Profession and Reaching out to the Public: Potomac Valley Architectural Foundation [PVAF]

#### **BACKGROUND:**

Established in 2009, the PVAF is a 501.3 (c) non-profit organization affiliated with the AIAPV chapter. It is the owner of the headquarters of the AIA PV chapter, the LEAFHouse, a US Solar Decathlon 2007 winner designed by University of Maryland SOA students. The PVAF serves as a separate body focused on supporting and maintaining the LEAFHouse as well as fund-raising body, endowing scholarships, and creating community outreach opportunities. The LEAFHouse also serves as a learning lab.

In the PVAF's third year, the president resigned abruptly without having established a plan or strategies. Additionally, the University of Maryland from whom the PVAF had purchased the LEAFHouse owned the land and was rezoning the area. The board invited Randy to take the role of president and she accepted.

#### **RESULTS:**

# Served as Treasurer 2010 - 2012 and President 2012 - 2017 First Allied Professionals added to PVAF BOD:

To improve collaboration between construction professionals and architects, she invited three AIA PV Allied Members to the PVAF Board. They provided additional expertise in the maintenance and repair of the LEAFHouse.

**Organized the first PVAF BOD Retreat:** She founded this retreat which became an annual event. **Charged PVAF Board to focus on three goals** for PVAF 10<sup>th</sup> Anniversary which were enacted during her presidency with the powerful teamwork of the Board

Endow more funds and types of scholarships

# **Revised By-Laws and Created a Mission Statement:**

University of Maryland changed its' land lease which required her to revise the PVAF by-laws.

## First Annual PVAF GOLF OUTING created:

Through her strong organizational experience, a golf outing on the University of Maryland [UMD] golf course was created which resulted in raising \$4000 in its first year in 2014 and has become an annual fundraiser.

# First PVAF/Montgomery College Scholarship:

Funds from the PVAF GOLF OUTING have allowed the PVAF to contribute \$1,000 annually to Montgomery College [MC] Architecture Program students to support their pursuit of a four-year architecture degree. **Additional University of Maryland Student Scholarships:** Funds from the PVAF GOLF OUTING have allowed the PVAF to increase their scholarships of \$3,000 for UMD graduate students and \$2,000 for UMD undergraduates.

# **Creation of a PVAF logo:**

A new logo was created as the PVAF re-branded itself in order to energize awareness of the foundation.

# Serving the Profession: AIA Leadership [Local] AIA Potomac Valley [AIA PV]

Randy Steiner's roles in AIA PV ranged from **President to Chairperson of Membership to Board Member for thirteen years from 1994 through 2007.** She directed her energy to expanding membership of Associates and Allied professionals and stronger communication with membership in terms of website and beginning social media.

#### **BACKGROUND:**

As a "suburban" chapter located just outside of Washington, DC and the AIA|DC chapter, there was membership competition for architects who lived in Maryland but worked in DC to join AIA PV. There was financial challenge of high rent for the rental of the chapter's suburban townhouse. There was no representation of the local community college architecture program in the chapter There was no pressing need for architects to join AIA at the time as there were no required continuing learning units until 1998. Additionally, acquiring hard copy of AIA Documents was conveniently available at AIA National Headquarters in DC.

#### **RESULTS:**

Second woman president of the AIA PV after 48 years in existence in 1998.

**First AIA PV Board Annual Retreat**: To empower the AIA PV Board, she established an all-day retreat at the start of her presidency to develop long-term planning. It continues to be an annual event.

**First AIA PV Women in Architecture Dinners:** Randy hosted monthly dinners began in 1998 for women AIA PV members and prospective women members in local restaurants which had women chefs.

**First monthly AIA PV Newsletter** was introduced in 1998 by Randy. Written on the computer but mailed in hard copy, it was replaced in 2001 with an on-line newsletter.

**First "AIA PV Architecture Week" 1998** was a week of talks as well as a walking tours. She initiated the event and a committee was formed to help it happen. It continued until 2011.

First "Tour Architects' Homes" was created by Randy as part of the AIAPVC Architecture Week 1998.

# **Advancing the Profession through Architectural Education**

Randy Steiner began teaching at Montgomery College Architecture Program in 1990. Her intention to merge her skills as an architect with her commitment to improve the prospects of the diverse population at the community college was inspired by her experience in the classroom.

Engaging in the social, cultural worlds of a diverse student body revealed to her an underserved and highly dedicated group of future architects.

In September 2018, Chronicle of Higher Education ranked MC as the most diverse community college in the Continental U.S. [Over 167 countries are represented at MC.] Within the architecture classes, it student population was over 50% Hispanic, 18% African-born, and roughly 12% Asian/Pacific according to her records since 2007.

In 2015, she was honored to be the **first AIA Maryland Educator of the Year Award ever**. In 2016, she was named the **AIA PV's Paul Kea Award winner** for her contributions to the community and education of future architects.

#### **BACKGROUND:**

Awareness of CCAPs is very limited. Knowledge of the program at Montgomery College was so limited that it was not even listed among programs distributed by the College to local high schools. Steiner learned of its' existence while reading the "Job Openings" in the Washington Post in late 1989. Lack of familiarity within local public and private middle and high schools meant no contact between the Program and the schools counselors and faculty. The local professional architectural community and general public were not familiar with the Program.

No communication with the local schools of architecture [University of Maryland [UMD SOA], Catholic University of America [CUA SOA], Howard University [HU SOA], or Morgan State University [MD BSAE] existed. Courses suitable for Continuing Education for architects had not been developed and therefore, enlisting local MC Architecture students for internships was rare. Lastly, opportunities for MC [nor other CCAP students] to participate in design competitions did not exist due to the ACSA and AIAS restrictions limited participation to 3rd year students.]

#### **RESULTS:**

Created the MC Student Architects Club to align with AIAS

Organized GREEN WEEK, week of speakers and workshops on sustainable design in 2007 - 2009 Established the MC Architecture Advisory Council composed of local AIA members Founded MC PVAF Scholarship Awards

Started the Certific te CAD for the Building Professional and Principles of Sustainability Successfully Obtained MC funds to renovate of CAD Lab and Architectural Studio and Hallway of the Arch Program.

Participated on MC Green Team to analyze the campus energy consumption in 2006.

# Advancing the Profession through Architectural Education: Beyond the College

Due to replacement of drafting classes with computer tech classes in public high schools in Montgomery County as well as other counties in the U.S. in the early 1990's, high school students had no opportunity to explore drafting, building construction and design and the career possibilities of architecture. Drafting classes were relocated to vocational programs only.

# **Challenges:**

CCCAP 2019: Anticipating the upcoming ARForum 2019 in Chicago, it was invaluable that leadership from NAAB, ACSA, AIA, and NCARB convene with CCCAP members to better comprehend the CCAPs. Providing CCCAP members with the most current trends in computer graphics was instrumental to the conferences. The chance to share specifics about challenges within the CAPs' outreach and academic was extremely worthy.

CCCAP 2018: Due to NYC high costs, obtaining space and negotiating planning for the CCCAP were difficult Successfully being granting a National Science Foundation Grant BEPrep grant [\$750,000] to encourage more CCAPs to participate in CSI Document Technologist examination prep was important to share with the members. Encouraging CCAPs to participate in early teaching about NCARB changes in accreditation and IPAL were crucial in 2018.

*CCCAP 2017:* A two-day conference of workshops and panels was suggested by Steiner at the conclusion of the CCCAP Conference 2016 and was 100% endorsed. To obtain a meeting space and develop a schedule required negotiations with several AIA chapters until one was selected as the site. All sessions were to be worthy of AIA Learning Units.

*CCCAP 2016:* Seeking a meeting site near the AIA Convention Center in Philadelphia required consultations with schools of architecture in the city which were supportive of the CCCAP mission. To fully engage the membership as active contributors to the conference sessions, 75% of the sessions were to be prepared and offered by members as well as representatives from NAAB and NCARB.

## **Role for all CCCAP conferences:**

Randy Steiner was the event planner, schedule coordinator, and program liaison of the CCCAP conferences. She prepared the format, site and food contracts, and promotional flyer and brochure. She acted as liaison with speakers and negotiated contracts. She formulated the events.

# **Challenge:**

No such compilation of information about community college architecture programs existed in 2009. Neither the ACSA nor AIA could provide the facts upon Randy's request and efforts. Creating a coalition of faculty and administrators from fifty states and from urban, suburban, and rural communities in a meaningful way was mandatory if one wanted enact change.

A survey based on data collected on-line as well as telephone calls to colleges and letter writing was needed.

Organizational skills, time, and funding to collect/ collate the data as well as support by the professional architectural community were required.

The NAAB Accreditation Review 2014 was seeking suggestions nation-wide regarding new standards for accrediting ACSA schools. The CCAPs had the chance to make recommendations.

To shift a mindset and cultural, financial understanding of the CCAP graduate demanded someone with a commitment and willingness to handle possible discouragement or confrontation.

#### Role:

In 2007, Randy took a one-semester sabbatical. By 2011, a list of community colleges offering associate degrees in architecture reached 155 programs.

Under her guidance, a survey was distributed and by 2014, over 122 programs had responded after her persistent tracking. This data formed the basis for the Coalition. The survey included: contact person, addresses, registration status, type of associate degree, website, #/gender/race of full-time and part-time faculty as well as #/gender/race/full-time status of majors and graduates, # of graduates, articulation status, and relationship with local AIA chapter.

Having obtained the support of the AIA DIVCO, a meeting was convened in 2012 and 22 CCAPs attended. The Coalition of Community College Architecture Programs [CCCAP] was founded by Randy Steiner in 2012.

# **Generating Endorsement of CCAPs** *Public Speaking at ACSA Conferences*

# **Challenge:**

Following her instincts, Randy believes that CCAP graduates are a valuable asset to our profession. Investigating how to inform architects, academics, and the general public of the restrictions preventing acceptance of CCAP courses and degrees to accredited universities was important to her. Public speaking engagements were a good tool.

#### Role:

Through her capacity as a leader in the AIA PV and PVAF, she pursued opportunities to serve on ACSA committees and worked with faculty at Morgan State and UMD and CUA. As the instigator and analyst of the CCCAP survey data she wrote and presented her ACSA presentations often traveling at her own expense.

#### **Outcomes:**

**Recruited to serve on ACSA/NAAB Certification Task Force 2019** as representative of community college architecture programs to review status of articulation and transfer issues.

Invited to join the NAAB Accreditation ARForum 2019 in Chicago as "invited guest" Encouragement of other CCCAP members to present at conferences. Erlene Clark AIA [Austin College] presented at "Beginning Design 2020" Workshop in Denver, CO sponsored by the National Conference on the Beginning Design Student.

Approval of her proposal to present "The First Hundred Days as a CCAP Architecture Student" at the ACSA Annual Conference 2018: With growing recognition of Coalition, the presentation was made and published on the ACSA website.

Participated in four ACSA Annual conferences and three ACSA Administrators conferences between 2014 and 2018: After attendance at NAAB Forum 2013, the data collected by the CCCAP surveys was recognized as potentially valuable to the accreditation process. Such data had not been available.

Acceptance of proposal to present at the AIA National Convention 2015: The session drew a crowd of 20+ attendees. It was the first session on community college architecture programs ever at an AIA event.

Requested to join the newly formed ACSA Education Committee in 2015: Resulting from successful transfer agreement between MC and UMD SOA, UMD leadership encouraged her inclusion in ACSA.

Invited to join the NAAB Accreditation Forum in Utah, 2013: Her invitation resulted from her persistent requests to discuss CCAP with NAAB leadership [Andrea Rutledge, former NAAB Executive Director].

Ripple effects were her conversations with the many ACSA deans.

**Summoned to join as a panelist and co-facilitator at the ACSA 2013 Administrators' Conference:** Stemming from her submittals to present about the CCCAP surveys to the ACSA

**Resulting from her ACSA presentations, a tipping point occurred - CCCAP became recognized as a worthy partner in the education of future architects:** Her presentations focused on the population of the CCAPs, the excellent design work of the CCCAP Student Design Competitions, the willingness of the CCAPs to develop transfer relationships, and the positive impact of "widening the pathway."

# Providing Opportunities for CCAP Students Creating Student Design Competitions [SDCs] through the CCCAP

# **Challenges for Student Design Competitions:**

An important aspect of becoming an architect is design development and presentation of design solutions with graphic and technical skills. To advance one's understanding of the profession, this aspect is fundamental. To impress the professional community as well as the general public, this issue is unmatched. However, due to restrictions of the student design competitions which limited entries to only 3rd year and above students in ACSA member schools, there were no opportunities for CCAP students to participate.

#### Role:

One goal of the CCCAP was to sponsor Student Design Competitions for CCAP students. Two years after founding the CCCAP, the first SDC was announced! She prepared the M-S-XS Portable House for the first CCCAP SDC 2015. She co-wrote with Jane Ostergaard AIA [College of DuPage] the CCCAP SDC 2016 design program, Interfaith Chapel of Peace. Randy invited several AIA members as jurors and as witnesses of the students' excellent work.

The SDC Committee was formed with Ostergaard as chairperson and CCCAP membership to help form future design programs for CCCAP SDCs. She handled the publicity and news releases for the CCCAP SDCs.

#### **Outcomes:**

Participation of 113 CCAPs and ACSA accredited programs

Participation of 217 students: None had been allowed to participate in SDCs before the CCCAP SDCs.

**National Recognition of Winning Students, their Instructors, and their College:** News releases were sent to the AIA local chapter and the College Public Relations. Prizes were copies of Architectural Graphic Standards. Teams were allowed to encourage teamwork, an often-overlooked aspect of design work.

# Providing Opportunities for CCAP Students Local Community Sponsored Student Design Competitions [SDCs]

#### Role:

Randy Steiner is a passionate advocate for increasing awareness of architecture as a career choice. While serving as Program Coordinator of the Architecture Program at MC for over 25 years, energized growth was always important. Serving as the originator for new curriculum and design projects, she was able to expand acknowledgement of the Architecture Program through different departments and divisions of her College and the local architectural community.

### **Outcomes:**

# **Establishment of MC/Torti Gallas Architects Design Competitions:**

In 1999, Steiner wrote a design program for a "Campus Bus Shelter" on the Rockville Campus. With no such shelter on campus, MC Facilities Office was welcomed id as. She asked the local AIA PV member office Torti Gallas Architects to be the jurors. The firm served as the ju ors as well as offered cash prizes and a summer internship for the first-place winner

The Competition was repeated annually for three years with the "Band Shell", "Clock Tower", and "Place of Peace." Thuy Do, MC'12, Morgan '14, UMD M.Arch '16 now works there.

# Relationship between MC non-academic Office and Architecture Program:

In 2002, she reached out to the campus on-site Child Care Services and offered for her students for design services. The Child Care Services were planning to renovate and were eager for ideas for their Rockville site. Child Care Services staff and two local AIA PV architects worked with student teams. In 2004, she initiated student competitions to redesign the Child Care Services' playgrounds on the two different campuses. Local architects served as jurors and the Child Care Services began fund raising efforts and built both the student designs!

In 2009, Steiner was invited by Library Services to develop schemes for future renovations of the Rockville Campus Library! She worked on a complex program for the renovation of the existing structure. The winning team of students received cash awards and an article in the College Alumni magazine.

Relationship with local town of Gaithersburg and Architecture Program: Asked by the Gaithersburg Community Museum Community Manager to develop ideas for a possible renovation of the 1884 historic train station headquarters, she invited students to develop schemes which they presented to the City of Gaithersburg. Despite a lack of funding, the schemes were displayed in the hallway of the Mayor's Office It was good exposure of the value of good design and the potential of being a student of architecture at the local community college.

# **Reaching Out To The Public: AIA Leadership**

# **Challenge:**

Good design is often misunderstood or ignored by the general public. The public perception is often stilted with images of monumental grandeur. The experience of working with an architect is not a common one. Unlike contractors, architects also rarely advertise or erect signs at their projects. Many architects who live in the Maryland suburbs, work in Washington DC. The AIA PV chapter located outside of DC competed for members.

#### Role:

Randy Steiner takes her volunteer commitments as a seriously as her commitment as an architect. As President 1998 AIA PV, one goal was to increase participation of chapter members and to build excitement about design in the County. **She introduced the idea of an Architecture Week** an Architecture Film Festival in 2006. **A committee for construction tours and talks on "How to Work with an Architect?" was formed.** Tickets to all events was free. Ads were placed in local neighborhood newsletters and the Washington Post.

As President PVAF, the first PVAF Retreat to brainstorm outreach was formed. Teaming up with Allied Members who were reps of one of the largest masonry suppliers in Maryland, a day on UMD golf course was "acquired pro-bono." Students at UMD SOA prepared a scripted tour of LEAFHOUSE [US Solar Decathlon 2007 structure designed by UMD SOAP students.] Tours of the PIAF-owned building began in 2013.

As Program Coordinator of the MC Architecture Program, a "Green Week" with speakers and design projects available to the general public was designed. Steiner also did the scheduling and created a service project using only recycled materials to remodel a campus lounge.

#### **Outcomes:**

**Architecture Week sponsored by the AIA PV chapter:** Begun in 1998, it was offered again in 2006 and 2011. **Architecture Film festival sponsored by the AIA PV chapter:** Steiner planned a festival including "The Fountainhead", "My Architect", an "Sketches with Frank Gehry," The theater was sold out.

**Golf Outing sponsored by the PVAF:** The Golf Outing, first offered in 2012, raised over \$4000 for scholarships for UMD SOAP and MC Architecture students. Architects, clients, and construction contractors played 18 holes and had a one-hour LEU session! This annual event continues to be held in April and offers AIA PV members a chance to socialize with contractors and potential clients. As a fundraiser, it has raised an average of \$4500 per year and has provided scholarships to two UMD grad students, two UMD undergraduate students, and two Montgomery College Architecture Program graduates since 2012! **LEAFHouse Tours sponsored by the PVAF:** School students and UMD AIAS members tour the house regularly since 2013.

Barbie Dreamhouse Design Competition" sponsored by the AIA Diversity + Inclusion Council: randy engaged the MC public schools with the contest.

**Green Week 2007 and 2008 sponsored by the Architecture Program MC:** The campus response to Green Week was the creation of the current Environmental Club with members across the campus.

Approximately 41% of graduates of architecture degrees are female according to ACSA data in their 2018 report. [https://www.acsa-arch.org/resources/data-resources/women]

"Women occupy just 10% of the highest-ranking jobs at the world's leading architecture firm while 16 firm have no women at all in senior positions" according to a DeZeen survey of over 1100 architectural firms internationally. [https://www.dezeen.com/2017/11/16/survey-leading-arachitecture-firms-reveals=shocking-lack-gender-diversity-senior-levels/]

#### Role:

# "Ever Think of Becoming An Architect?"

Under her initiative, the concept of a hands-on workshop was created including a model making project and brochure. Steiner solicited Scott Knudsen AIA to create an architectural element scavenger hunt which was challenging but fun.

# "Every Girl Can"

Invited by the director of EGCLI to be a panelist and presenter at the all-day workshop, he prepared the format of a model-making session and prepared a promotional flyer and b ochure for the girls.

# "Design Like A Girl"

Solicited by Joanna Schmickel AIA to serve as a one-on-one student mentor for a workshop with a black box theater tour and a student design activity for a fairy tale stage set, Randy worked with AIA DC chapter.

#### **Outcomes:**

**Data Base of 400+ contacts:** Steiner developed a list of contacts at public and private middle and. high school math, art, and career technology faculty for the "EVER THINK" workshop. This data base was used by all the workshops

**Focus on Girls but Open to All**: Wording in all flyers for the "EVER THINK" Workshop were gender-free. In fact, the turnout was 50/50 female/male students.

**Creation of Prototype Workshop Design Projects:** Archetypes of design challenges, games, and demonstrations were created and used at all the workshops as well as for the high school summer class.

Follow Up with Participants: Email messages were sent update to the data base.

**Inclusion of Arch Students as Volunteers:** Architecture students were included in community service projects to serve as mentors. They volunteered at "EVER THINK," "EVERY GIRL CAN," and in DC Cares to paint murals **Introduction that Community College Architecture Could be an Option:** Steiner encouraged pursuing an architectural education in whatever financial cultural, or academic pathway possible. Many people did not know that community college could be a start to architecture.

# **Envisioning the Future by "Widening The Pathway"**

# **Challenge:**

It is a time of uncertain economy, increasing cost of college education, growing diversity among the population, and environmental drama. As Bruce Mau, author of Massive Change, spoke at the recent NAAB ARForum in July 2019 in Chicago, "when we fail to design we design for failure."

According to the studies of the AIA Diversity in the Profession of Architecture Executive Summary 2016 and the AIA Diversity in the Profession of Architecture Key Findings 2015, NCARB Education Report 2018 [https://www.ncarb.org/nbtn2018/education, CCCAP Survey 2014, NCARB Demographics Report 2018 "Gender Equity and Diversity Minimal Among Supervisors", US Census data, Bureau of Labor Statistics 2017:

Less than 22% of registered architects are women and less than 2% self-identify as minority. Enrollment of new students into architecture schools has decreased by 6% between 2007 and 2017.

An average of 1,439 graduate per year from the 122 CCAPs. Of these graduates, 32% or 458 self-identify as minority.

Less than 16 of the 130+ ACSA schools have confirme transfer agreements with CCAPs. Only 17% of women and 12% of minority architects serve as supervisors.

The US population in 2055 will be 57% non-white. In relationship to 2015, this represents a 13% increase of Hispanic ethnic population and a 17% decrease of white population.

Over 66% of the construction related labor force was Hispanic.

#### Role:

Randy Steiner is an energetic force in her commitment to "Widening the Pathway" to the profession. She is persistent.

As PVAF president, she invited several women to join the board including Loreen Arnold AIA who continued on the board for seven years.

As Faculty Advisor to the Student Architects Club at Montgomery College, she recruited women students to be run for office and for seven years, there were women presidents.

As founder of the CCCAP, she invited four women to join the 8-member board. Three of these women continue to serve after four years on the board. [The CCCAP has only been a 501.3(c) since 2014.] As an active promoter of the CCCAP, she served on one AIA National committee [AIA DIVCO], two ACSA committees [ Education Committee 2016 and 2017 and the Certification Task Force 2019], been to two NAAB Accreditation Review forums [2014 and 2019], and made eight ACSA presentations about the barriers preventing the transfer of CCAP students to ACSA schools.

As of Fall 2019, she will serve on the AIA|Baltimore FAR "Adopt-A-School" program fosters partnerships between local architecture firms and Baltimore City schools.

# **Validating Student Success With Work At Montgomery College**

# **Challenge:**

Upon the conclusion of "Introduction to Architecture and the Built Environment" [which is the first course required in the MC Architecture curriculum] is a capstone design project of a coffee shop to be located on the College campus but on a tropical site and according to the design philosophy of an award-winning contemporary architect.

Students must demonstrate a range of skills in **drafting**, **approach to design problem solving**, **model building**, **research of materials/site/climate**, **time management**, **and public speaking**. Teamwork and acceptance of constructive criticism among students is mandatory in the six-week final project.

This project offers students an exciting challenge for 1st year architecture majors as they engage in an appreciation of the complexity of design as well as the significance of research of sustainability, cultural, and aesthetic issues.

At the final jury, students display their increased self-confidence in front of a jury of local architects. **An** understanding of the process and time commitment informs students that this might be the right profession for them.

#### Role:

To have an impact beyond the day by day, Randy investigated how to make the first two years of education as an architect accessible and inspiring. The curriculum was revamped encompassing software and hardware trends as well as fine a ts and writing.

She has taught full-time and was responsible for "Introduction to Architecture + the Built Environment," "Introduction to CAD", "Professional Practice", and "Principles of Sustainability." She also taught "History of Architecture II."

For a ripple effect beyond the studio, she emphasized design thinking and focus on 3D form and critical thinking in all assignments and readings.

A Portfolio Workshop was offered by her twice a year to develop student portfolios for transfer and job interviews.

She created the entire McCoffee Shop project. It continues to be the capstone of the Introduction course.

#### **Outcomes:**

Over 50% of the students in Introduction to Architecture class continued as Architecture majors and graduated. [The average rate at community colleges is 14% of students in firs year classes will continue and graduate.]
