I understand that my friend, Ernest Born, is being proposed to the Jury of Fellows for Fellowship in the American Institute of Architects. His reputation is such that anything I might say may seem redundant but on the other hand it gives me great pleasure to speak of our association over the past years.

Ernest Born is as well known in the East as in the West. I believe he spent some ten years in New York at which time he was associated with many prominent architectural firms. My first association with him was when we jointly did the Brazilian Pavilion at the San Francisco Exposition for the Government of Brazil. His brilliant handling of the interior design was the chief contribution to the success of the building.

With the advent of World War II, Ernest Born and I found ourselves further associated with the Rubber Development Corporation's work in the jungles of Brazil. Together we worked on many design projects for proposed housing developments in Manoas and stations on the Upper Amazon. Although this work was never constructed, Mr. Born's fine planning and design ability was very apparent.

After the war, Ernest Born again returned to San Francisco and in the years that followed he has distinguished himself in private practice and in public service. He served most ably as the head of the Art Commission for the City of San Francisco for about four years commencing in 1947 and was personally responsible for the fine work of that Commission, notably in the improvement of the appearance of public works which are now appearing in our City.

Most recently Ernest Born has turned his hand to teaching and at this writing he is full professor in architecture at the University of California. Fortunately his professorship allows him time to carry on a brilliant private
