# Summary of Achievements

James P. Clark's leadership through the AIA has created programs that empower collaborative connections which harness and direct the collective knowledge and talents of architects, students and institutions to inspire awareness, creativity, education and excellence.

## Digest of Achievements/ Notable Contributions

James founded and is the chairman of the National Ideas Competition for the Washington Monument Grounds on the National Mall. This is a unique three-stage competition that focuses on public interest, education and creative thinking about the nation's most symbolic open space. The competition has attracted both national and international attention and has facilitated free discussion outside the highly sensitive political world of review agencies. As the president of the Virginia Society AIA, he inspired the AIA, George Washington University and architecture schools throughout the nation to sponsor the competition.

By founding and leading the Annual Inter-School Design Competition at the National Building Museum, James has brought students together to reinforce the value of designing projects in collaboration with others. Sharing the design process with others and displaying it to the public has resonated with excitement and promise for more than a decade. He used his influence as a board member of the AIA to bring together internationally renowned architects, schools of architecture, chapters of the AIA and the National Building Museum to make this happen.

Through School Connections, a model committee that he founded through the AIA Northern Virginia Chapter, James connected practicing architects, students and professors. With 15 years of joint effort, mentorship experiences abound through amazing programs under this committee. Students, as well as young and emerging architects, are encouraged to participate in competitions, design awards, portfolio reviews, emerging leadership programs, IDP programs, forums, seminars and tours. At the AIA's Grassroots, James encouraged AIA Chapters nationwide to connect with their local schools of architecture to form programs based on what he had developed. His efforts were recognized when he became president of the AIA Northern Virginia and the chapter won the National AIA Continuing Education System Award for Excellence.

As chairman of the Professional Excellence Commission in Virginia, James engaged universities across the nation in AIA activities by forming the Prize for Design Research and Scholarship and helped to establish the first Practice/Academy Summit which captivated a national audience. He encouraged leadership mentoring opportunities by working with his committee to form an Honors Academy for newly registered architects.

In his architectural practice, James promotes collaboration, bringing people together to shape great ideas. His current work for the National Museum of the American People was nominated as the "Best Unbuilt Museum" and provided the architectural vision, allowing Congressman Jim Moran to introduce a bill in Congress to establish a commission to investigate the feasibility of creating a museum which features our nation's ethnic diversity.

James' efforts toward public and professional collaboration were summarized in a new, vibrant, long-range plan he inspired to create while serving as president-elect to the Virginia Society AIA. It affirms that we serve each other through the AIA... if I make you successful, I will be successful. It maintains our objective to teach the public to see design as we see it and to value that which we value. It celebrates the fact that we, as architects, help to shape the built environment through research, understanding, knowledge and collaboration. The plan encourages interaction and collaboration between us all... young and old, individual designers, chapters of the AIA, students, professors, allied professionals, communities and more. It serves as a national model.

James' efforts represent the enormous potential for using the AIA as a vehicle to promote connections that reinforce tomorrow's leadership and inspire the creation of a better built environment.

James P. Clark created this innovative, three-stage competition that attracted international attention. The concept for the National Ideas Competition for the Grounds of the Washington Monument came out of a realization that, while the monument is the defining feature of the Washington, D.C., skyline and the centerpiece of the nation's most symbolic open space, at ground level its vast open space remains unfinished. The competition heightens public interest in the role of the Washington Monument grounds in the civic life of our democracy and achieves the following:

- Connects a wide array of professions, the general public, the AIA and universities from around the nation in order to increase awareness and education
- Promotes free discussion outside a highly sensitive and political review agency arena
- Inspires creativity and awareness for the future of this significant site in our nation's capital
- Engages the public through the People's Choice Award and two exhibits that are occurring in conjunction with the 2012 AIA National Convention.
- · Marks our moment in history

During his tenure as president of the NOVA Chapter of the AIA, James P. Clark led the chapter to achieve far-reaching results as well as extend the chapter's impact statewide, regionally and nationally.

- Initiating sources of meaningful professional development: In early 2005 AIA NOVA participated in a successful regional event DesignDC. James then worked with Virginia Society AIA to create the "Symposia" for 2006. The chapter was awarded the 2006 National AIA Continuing Education System Award for Excellence.
- Strengthening the relationships between AIA components: James was the bridge between Virginia Society AIA, the AIA Washington Chapter, Potomac Valley Chapter (Maryland), National AIA, Virginia Tech's WAAC and other allied organizations.
- Growing the Chapter with quality: While membership increased to an all time high, making the chapter the 18<sup>th</sup> largest chapter in the nation, the focus of James' leadership was on making the existing programs stronger. In 2005 he created a working executive committee to assure continuity from year to year.
- **Promoting membership interaction with a purpose:** The first annual family picnic made its debut during James' tenure. He celebrated the chapter's 30<sup>th</sup> anniversary with the reunion of past presidents at the annual meeting.
- Expanding outreach to the general public: Through James' encouragement, programs like CANstruction and the first annual exhibit of architect's artwork gave architect's visibility to the public.
- Educating about and serving as an information resource for the built-environment and good design: James promoted an awareness of environmental issues, historic issues, small firm challenges and much more through programs featured in Architecture Week and throughout the year.
- Connecting to community organizations and government entities: The "Citizen Architect" program was established to encourage member involvement and influence community organizations and government agencies.
- Encouraging interns, young architects and architecture students to be involved in the AIA: AIA NOVA helped convince VSAIA to reduce dues for associates. James expanded activities and interaction with schools of architecture, including through the annual student scholarship.
- James revitalized all AIA NOVA committees: He created a culture of strong leadership and accountability.

It was organized through a consortium of university professors, architects and historians partnering with George Washington University in 2010 and ending with a final "People's Choice Award" in May of 2012. The premise of the competition is to connect a wide array of professionals (architects, planners, landscape architects, historians, theater designers, futurists, artists, environmentalists, social advocates, etc.) and the general public (ages 12 and up) to increase awareness and education about the design of a significant national landscape.

The idea for this competition came out of the realization that while the Washington Monument is the defining feature of the Washington, D.C., skyline and the centerpiece of the nation's most symbolic public open space, at ground level its vast open space remains unfinished. This competition heightened public interest in the role of the Washington Monument grounds in the civic life of our democracy. 

Each year, the universities take turns developing the architectural program for the competition. The competition is held on a weekend in September in the Great Hall of the National Building Museum. 



Left with no record of contacts or the framework of the competition, James established a structure for the competition that restored the prestigious status of the prize that had dwindled with time.

James re-established contacts and developed written protocols that described the purpose of the competition and the procedural policies. In order to down-play the fact that some universities infrequently or never won the prize, James established Best of School and Honorable Mention awards for each participating school of architecture. Finally, a policy was established to present the awards to the students at a school or an AIA event. This has increased visibility of each school to the AIA and the profession. It has increased the prestige of the Virginia AIA Prize while uniting the professional and academic worlds.

# Virginia's Architecture Students Compete for the 2007 VSAIA Prize

On the last weekend of January, students from Virginia's four architecture schools competed in a charrette to determine the winner of the 2007 Virginia Society AIA Prize. Students received the topic at 5:00 pm on Friday, January 27, and had to submit their entries by 9:00 am on Monday, January 30.

The program for the competition rotates among the state's architecture schools, and for 2007 it was designed by Peter D. Waldman of the University of Virginia. This year, the challenge was to design an "Offshore Visitors Center 1607-2007: One Good Room with Four Remarkable Windows." The task was to create a room set

on a barge 30 feet wide by 120 feet long. The student was to envision the deck as the construction site of one room with four windows to view four distinct settlements of the student's selection or an invention constructed over the past 400 years. Each of the three windows facing east, south, and west was to frame one particular view. The north window was a distinct condition, perhaps a blank slate, a computer screen, and/or the mirage of the beginning and/or end. The site is on water and views are revealed by precise coordinates, and shuttered perhaps more often than not. This was the challenge that taxed the creative talents of all who accepted.

> Each school juried its students' submissions, forwarding up to eight winners per school to the Virginia Society AIA for final adjudication. The prize jury convened on March 9 and was chaired by VSAIA board member James P. Clark, AIA (MTFA Architecture). Also serving were: Timm Jameison, FAIA (SFCS); Randall Mars, AIA (Randall Mars Architect, VSAIA Board, AIA Northern Virginia Board); Vernon Mays (VSAIA staff, Inform magazine editor);

and Bob Middlebrooks, AIA (Clark-Nexsen Architects). Charged by Mr. Clark to seek "creative solutions that are based on strong conceptual ideas," the jury reviewed and discussed each of the 28 entries. The identities behind the individusubmissions and their respective schools were not revealed to the jury until after th adjudication process was completed. The awards are as follows:





#### **Synopsis**

This tropical river bank exhibit at the National Zoo is the first BioPark redevelopment for the display of both plants and animals. The traditional A/E design team was expanded to include plant, animal and cultural scientists with expertise in the tropical rain forest habitat. This collaboration resulted in a facility that authentically represents the Amazonian culture and community.

The 30,000-square-foot structure was developed to illustrate connections in the diverse aspects of the Amazonian Culture, including art, animals, plants and artifacts. The lower level of this exhibit consists of an area for viewing aquatic life below the "river's" surface and a gallery space features interpretive micro exhibits on the biology of the Amazon River. The upper level is a re-creation of the Amazon rain forest, teaming with trees and plants, insects, birds and other native mammals and invertebrates. This hands-on exhibit of an endangered ecosystem promotes conservation by using the building as a learning tool.

Since its opening, the National Zoo has seen increased attendance and this popular exhibit has been visited by thousands of children, school groups and tourists from around the world. The exhibit was designed to provide varying experiences and engages the interest of everyone from the young student to the scientist.







The design process for the Science Museum of Virginia was a highly collaborative endeavor. James P. Clark established a consensus among historic preservation experts, museum directors, scientists and the educational community. As a result, the museum provides meaningful educational experiences in children's lives.

Adaptive reuse and renovation of John Russell Pope's historic 70,000-square-foot train station into a science museum enhanced the building's orientation, circulation flexibility and science interpretation. While retaining the beauty of the historic spaces, the ambience of the building now communicates the thrill and excitement of science. The existing architecture has become an organizing, stable element that frames an environment that is constantly unfolding and changing. Attendance has dramatically increased since the renovation.





#### **Synopsis**

This museum will tell the story of all of the people who became Americans from the prehistoric period through today and is expected to attract several million visitors each year. The museum is envisioned to include more than 400,000 square feet of space devoted to exhibitions, collections, education resources, genealogical research, films and a major scholar's center. Located at the Banneker Overlook site, the museum will serve to link two central spaces in Washington, the National Mall and the Southwest Waterfront.

The concept design led by James P. Clark, AIA, envisions four soaring structures arising from the central grass covered roof of the central building recalling flags of nations over a landscape of waves. During the day, the textures of the concrete "flags" will constantly change with the movement of the sun's shadows across the facade. At night, films could be projected onto these surfaces. The design calls for a state-of-the-art green building that would serve as a model for the Southwest Ecodistrict. This will be America's only national institution devoted exclusively to telling the full story of the making of the American people.


