Best practices: Candidate qualifications

Qualified candidates should:

- Represent a broad range of talent and experience.
- Represent the values of AIA and the communities that AIA serves.
- AIA component leadership experience is desired but not required.

Best practices: Election practices

During the election process AIA will:

- Recruit and promote Strategic Council positions to all local and state components and to all component members.
- Create an open and transparent election process with a formal nomination and selection process.
- Involve the current Councilor(s) to support and assist engagement in the election process.
