

RE: EMERITUS STATUS

To clarify my enclosed application for emeritus status and, perhaps, to satisfy your curiosity about my past activities in the Institute and which particular rock I have been hiding under I add the following:

I joined the Southern California Chapter (now Los Angeles Chapter) of the American Institute of Architects as an Associate Member while working for Ulysses Floyd Rible, F.A.I.A., in Beverly Hills about 1937 or 1938. When I received my California State license to practice in 1942 I became a Corporate Member. In 1946 I established my practice in Pomona, California and have maintained that office ever since.

In the early 1950s, to forestall, regulate and control moves to fragment the Chapter by small groups eager but unprepared for separate Chapter status the Southern California Chapter moved to establish "branch chapters" as a preliminary step toward ultimate separate chapters. As I recall it was the first such effort in the national A.I.A. and they debated the issue for some time before granting approval.

Space does not permit my going into detail but I was the big mouth in the proper place at the proper time and I was appointed chairman of a committee to establish the first branch chapter of the Southern California Chapter in the area from Pomona to the Salton Sea. In due time the branch chapter, titled the "Inland District", was formed and I became the first "Chairman". That was the title of the honcho who ran the show. Others instrumental in the organization effort were J. Dewey Harnish of Ontario, Herman Ruhnau of Riverside, Robert Chambers of Palm Springs (later of Santa Barbara) and Robert Thomas, then of Apple Valley. I was Chairman for three years and was followed by Herman Ruhnau for at least two. Stanley Meston of Fontana, as I recall, followed Herman as Chairman.

In the middle 1960s the organization was large and strong enough to run its own show. The break was made with the Southern California Chapter and the Inland California Chapter was officially recognized. With the formation of the Long Beach Chapter and Orange County Chapter the name Southern California Chapter was no longer appropriate and was changed to Los Angeles Chapter.

SUBJECT: DELINQUENT DUES VS. EMERITUS STATUS REFERENCE ID 6324156

President Harry Truman reportedly had on his desk in the Oval Office a sign that read, "The Buck Stops Here". I hope I have finally reached a similar desk.

Thank you for your letter of July 27, 1988, received August 12, 1988, regarding my "delinquent dues". After 46 years of corporate membership, preceded by five years as an associate member, I do not take my membership obligations lightly. Nor will I, in this brief letter, outline the blood, sweat and tears I have shed in the service of the American Institute of Architects.

On November 12, 1987, and holding a paid up dues receipt for 1987, I filed with the Inland California Chapter an application for emeritus member status, a copy of which is attached, along with my check for \$40.00 for mailings, etc. The Chapter office informs me that the application and check were mailed to the Washington, D.C. head-quarters immediately. When no apparent action had been taken and telephone inquiries were not answered a copy of both application and check were sent by registered mail return receipt requested. A duly signed receipt was returned showing that the application had been received. Subsequent telephone calls verified also that it had been received. However, your computer still spits out unpaid dues reports. The filing of the application while my dues were still paid should have relieved me from any further dues obligation.

According to the application I submitted I was eligible for emeritus status when I reached the age of 71 years. However, I still paid dues through 1987 when I was 78 years old. That means I have paid in dues and charges to the National, State and Chapter levels approximately \$4000 that I should have been relieved of.

The failure of the National A.I.A. office to acknowledge and process my legally submitted application for emeritus membership status has been and is a continuing concern and embarrassment to me. I find that I am not the only appplicant who has been treated shabbily. J Dewey Harnish, FAIA of the Inland California Chapter on last report has fought the same battle for well over 18 months. Furthermore, at the July 1988 Inland California Chapter Board meeting I attended, an applicant was informed by an embarrassed Chapter President that it might take up to 18 months for the National office to process his application. Need I say more?

It is your disgrace, not mine, if this is not cleared up and I do not receive the entitlement due me. I will appreciate your acknowledgement that the buck has finally been stopped at your desk and that I am, after 10 long months, acknowledged and recognized as a member emeritus of the A.I.A. Thank you.
