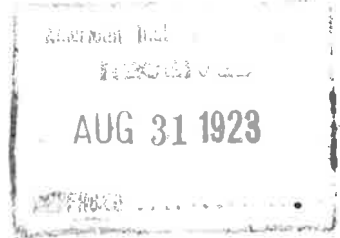

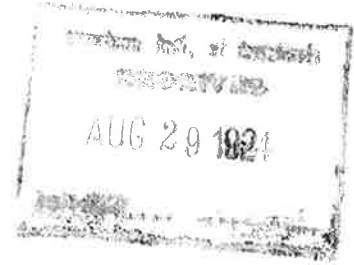

With regard to Messrs. Marcus Gilbert Miller and Charles Frederick Owsley, their applications were received in 1923-that of Mr. Miller having been received on May 29; and that of Mr. Owsley having been received on April 18.




Dear Sir;- Since the meeting of the Architects in Akron on the 20th of February I have decided against the filing of the formal application which you gave me and am returning same to you.



The Secretary of the Eastern Ohio Chapter of The Institute has forwarded to this office your letter of March 14th requesting readmission to membership, and your check for \$25.00 in payment of your past due note to The Institute in that amount, which is acknowledged with appreciation.

The Chapter advises of its recommendation that your past Institute dues be waived by action of The Board of Directors of The Institute, which will meet this month just preceding the annual convention and convening on April 20th.

At its December 1944 meeting, The Board had before it a large number of applications for readmission, contingent upon the remission of indebtedness for Institute dues owed at the time the memberships terminated.

There was extended discussion of the policy involved in this procedure, with due regard to the fact that special circumstances exist in many cases - usually with respect to those former members who encountered hardships during the depression years.

As a result The Board adopted a general rule to the effect that all former corporate members, whose applications for readmission to membership and for remission of past dues had been received, should be requested to submit a statement in some detail giving reasons why the indebtedness for dues might be waived.

Dear Sir;- I have deliberated over your letter of April, 5th and will say that the note which I have now paid was issued as a result of depression years. However immediately following I did stop attending Chapter meetings as a result of unethical practice on the part of two Chapter members, now no longer members, who on one hand cut commissions and on the other solisited work from a Client who at the time had given me his work. The Client in question being an Automobile dealer and accustomed to "horse trading" could not understand why he should be obliged to hold to a promise when I refused to agree to include the purchase of a new Auto as a part of my commission, and as my competitor suggested as a consideration. At the time there seemed no remedy against the re-occurrence of such practices and my reaction was one of disgust.

I do feel that conditions over the State are greatly improved, and having served on the State Board of Examiners since the Law was enacted, and that our Board in reaching every man has in a measure caused the practicing Architect to be more conscious of the standards and the plane upon which each should conduct their respective business. Walking out on any situation is not ordinarily a part of my makeup, and so I leave the decision with you.
